- support the objects, bylaws and codes of conduct of the association.

Ordinary Membership

Ordinary membership of the association is open to organisations that:

- Ordinary members must be at least 18 years of age and support the objects, bylaws and codes of conduct of the association;
- Subject to rule 17(1), ordinary members are eligible for election to the board of the association;
- Ordinary members are not entitled to vote at general meetings of the Association.
